THE OLDHAM – UNION STREET/SOUTHGATE STREET/HOBSON STREET TEMPORARY PROHIBITION OF DRIVING & WAITING ORDER 2012

The Oldham Borough Council on 16th January 2012 made a Temporary Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to prohibit vehicles from proceeding along that part of Union Street from its junction with Greaves Street to its junction with Clegg Street and along the entire length of Southgate Street from its junction with Union Street to its junction with Emmott Way and Rhodes Bank and along that part of Hobson Street from its junction with Phoenix Street to its junction with Union Street. The order also prohibits waiting without disabled badge exemptions on the diversion route for the Union Street prohibition

The alternative route for the Union Street prohibition of driving will be via Greaves Street - from its junction with Union Street to its junction with Ashworth Street/ Ashworth Street from its junction with Greaves Street to its junction with Clegg Street/Clegg Street from its junction with Ashworth Street to its junction with Union Street. The order also prohibits waiting without disabled badge exemptions on this diversion route.

The alternative route for the Southgate Street prohibition of driving will be via Union Street/Waterloo Street/Rhodes Bank

The alternative route for the Hobson Street prohibition of driving will be via Phoenix Street/Brunswick Street/Union Street

The Order is to be made to allow metrolink works to take place and will be in force for a maximum period of 18 months from 16th January 2012 or until the works have been completed, whichever is the earlier.

**THE OLDHAM – HOBSON STREET/SOUTHGATE STREET/UNION STREET
TEMPORARY PROHIBITION OF DRIVING & WAITING ORDER 2012**

The Oldham Borough Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby make the following Order:-

1. This Order shall come into operation on the 1st January 2012 and may be cited as The Oldham – Hobson Street/Southgate Street/Union Street Temporary Prohibition of Driving & Waiting Order 2012 and will continue in force until the 14th July 2014
2. No person shall cause any vehicle to proceed in that part of Hobson Street from its junction with Phoenix Street to its junction with Union Street
3. No person shall cause any vehicle to proceed along the entire length of Southgate Street from its junction with Union Street to its junction with Emmott Way and Rhodes Bank
4. No person shall cause any vehicle to proceed along that part of Union Street from its junction with Greaves Street to its junction with Clegg Street
5. No person shall cause any vehicle to wait in that part of Greaves Street from its junction With Union Street to its junction with Ashworth Street and in that part of Ashworth Street from its junction with Greaves Street to its junction with Clegg Street and in that part of Clegg Street from its junction with Ashworth Street to its junction with Union Street
